SUB: WITHDRAWAL OF INSPECTION COMMITTEE CONSTITUTED FOR EXTENSION CASES OF AFFILIATION- REG.

As per clause 11.2 of Affiliation Bye Laws, 2018, the Board may cause inspection of an affiliated School done at the time of extension or after specified periods any time during the affiliation period. The periodicity, of such inspections shall be determined by the Board from time to time".

In this connection, it is observed that the Inspection of schools that has applied for extension has been held up due to current COVID-19 situation in which schools are not functional. However, the schools are pressing hard for extension of affiliation as school has to take further necessary approval from State Education Department/other govt authority etc to ensure normal functioning of school.

Keeping in view the fact mentioned above, the Competent Authority of Board after due consideration and reviewing the present COVID-19 situation has accorded following approvals:

- 1) All Inspection Committee constituted / cases where Inspection has not been done yet are stand withdrawn with immediate effect.
- 2) The Inspection committee that had completed inspection of schools applied for extension of Affiliation may submit report within one week from the date of this order.
- 3) The schools will be granted extension of affiliation based on details/data submitted by School in online application.
- 4) The cases where Inspection Committee is constituted with Deficiency/(ies) or Deficiency/(ies) is conveyed before Constitution of Inspection Committee shall be required to submit compliance against deficiencies communicated.
- 5) The onus of genuineness of the data/ documents/ information provided by the schools shall be of the school for all purposes.
- 6) The school will be required to comply with the deficiency/conditions communicated in the grant letter with immediate effect and shall keep the record intact for production before the Board/ Appropriate Govt. Authority as and when called for, failing which the Board reserves the right to take action as per clause 12.1 of Affiliation Bye-laws read with 12.1.9 which further leads to withdrawal of Affiliation.
- 7) The school shall also be liable for action by the appropriate Govt., in case of violation / non-compliance of the concerned Govt. norms.
- 8) The Board reserves the right to conduct inspection of school as per clause 11.2 and 11.4 of Affiliation Bye-Laws.
